- CHEQS Magazine A meeting is to be held on 7th November at 7.30pm, at Southrop Village Hall, to discuss the future of the CHEQS magazine. Everyone is welcome to attend. Various options were considered, with a majority of Cllrs agreeing that they would support the continuation of the magazine, but as a community magazine, rather than a church magazine.
- **Letter from Mrs Davey** has been received regarding the overhanging trees/shrubs in the village. This matter requires property owners to cut back any

- overhanging greenery and it was agreed to publish an article in the next edition of the CHEQS magazine.
- Traffic calming Mr A Stanbury has approached the Council regarding options available for traffic calming in the village. Discussion took place regarding the increasing number of vehicles that use Southrop as a cut through to and from Carterton to Fairford. It was agreed to contact the Commander at Brize Norton to advise him of the problems being experienced and to seek his help in resolving this matter.
- Condition of road between Southrop and the A361 Cllr P Brickley has been in contact with W.Oxon District Council and Cotswold District Council regarding the poor and dangerous condition of this road. He will continue to pursue this.

The Council agreed with the Village Hall's plans and following debate it was **RESOLVED** to grant the SVH up to £10k (nett of VAT) this year. Proposed Cllr C Brickley, seconded Cllr Jones — all in favour. It was agreed that 3 quotes are required for goods and invoices which should be made out to Southrop Parish Council.

Consideration was given to the method that should be used to determine the Precept figure for 2020/21. It was agreed to consider this matter in depth at the next

meeting, before sending this out for consultation with members of the community. This will be published in Draft for comment. A final decision to be made in early January. It was agreed, in principle, to use the RPI or CPI index figures in the final calculations.

The matter of verges was discussed at length and it was agreed to contact Glos. Highways and County Cllr Theodoulou to seek advice on the best way of preserving the verges. This matter to be deferred to a future meeting to allow time for a meeting to be arranged between members of the Council and Glos. Highways.
