- Speeding. As Chair of Environment & Scrutiny Committee, he will be looking at speed limits, calming measures, enforcement, technology. New Police Commissioner is very interested in speeding issues and better communication regarding the Police and Town & Parish Councils is expected. Discussion took place about the new speed monitoring devices brought to the attention of this Council over a year ago. Formal approval for the device is still awaited.
- Conservation
- Sewage & Rivers
- Rural Crime (working with Chris Nelson)

Cllrs expressed their concerns regarding the state of the roads inside the village, caused by past works of companies such as Gigaclear and Thames Water. Very bad potholes on the road surface near the school. The top surface of the road is crumbling with small potholes appearing revealing metal works below. Cllr P Brickley also raised the issue of the red barriers on the bend just over the bridge going out to Filkins. These were put up in 2019 and numerous requests for these to be removed and remedial repairs to be carried out have been ignored.

Cllr Morris was informed of the issues relating to the Planning Dept at CDC and he said that he would talk to Cllr Theodoulou who is the District Cllr. Cllr Morris requested that a list of matters should be sent to him prior to the next meeting.
